- Business license payments are due on **March 1st**. After **March 31st** a 10% penalty with a \$10 minimum will be applied.
- Any changes in name, address or classification requires a new business license application.

Financial Services: Consumer Financing, Installment Financing, Mortgage Companies

Real Estate Services: Appraisers, Lessors and Rental Agents for Real Estate Owners, Operators and Lessors of Building or Mobile Home Sites, Real Estate Agents, Brokers, Managers, Selling Agents

Repair, Personal, Business, and other Services

Amusements, Barber/Beauty Shop, Billiard Parlors, Photography, Funeral Homes, Motels, Janitorial Services, Laundry/Dry Cleaning, Theatres, Shoe Repair Shops, Taxies, Auto Repair
