Proposed Budget – Fiscal Year 24-25

The Narrows Town Council will hold a Public Hearing on the proposed budget on Monday, June 10, 2024, at 6:00 P.M. or as soon thereafter as may be heard, in the Town Hall, located at 210 Main Street. All interested citizens are invited to attend and offer comments on the budget.

There are no increases to Real Estate, Personal Property, Mobile Home, or Machinery/Tools Tax. There are no changes in the cost of Motor Vehicle or Motorcycle decal fees.

Water and sewer rates are increasing by 10%.
